## Investment Objective

Seek to maximize risk-adjusted total return by systematically pursuing relative value opportunities throughout all sectors of the fixed income market.

## Investment Philosophy

Reams defines risk as permanent loss of principal or the inability to meet investment objectives. This is distinct from other investors who may define risk as volatility or tracking error versus a benchmark. Another differentiating feature is that Reams focuses on reacting to relative value opportunities and taking advantage of volatility, rather than relying on economic forecasting and predicting market movements. These guiding beliefs lead the team to:

- Focus on long-term value and total return;
- Employ both top-down macro and bottom-up strategies;
- React opportunistically to valuation discrepancies and volatility;
- Create diversified portfolios that seek to outperform over a full cycle; and
- Seek opportunities to add value in niche parts of the market overlooked by larger managers.

## Fund Overview

- Invest tactically across all sectors of the fixed income market including investment-grade and high yield credit, governments, agencies, mortgage-backed, asset-backed, non-US dollar and emerging markets.
- Actively manage overall portfolio duration based on market conditions, normally within a range of -3 to 8 years.
- Maximum exposure to non-investment grade securities of 60%; maximum exposure to mortgage-backed and asset-backed securities of 60%; maximum exposure to emerging markets securities of 30%.
- May use derivative instruments such as futures, options and credit default swaps in order to gain exposure and manage risk.

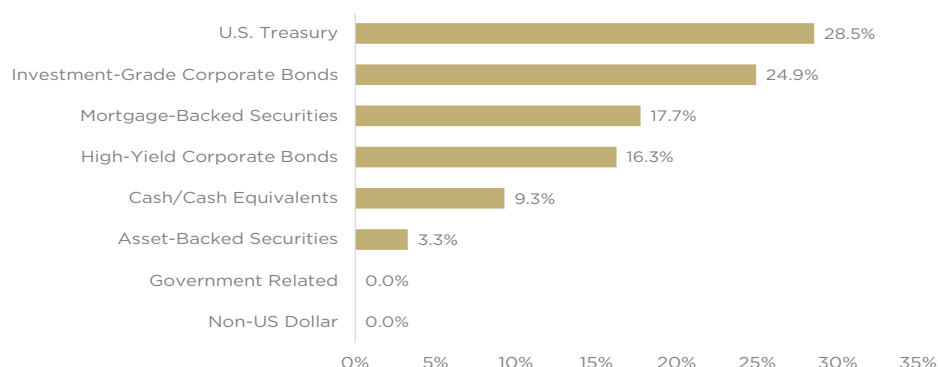

**Sector Allocation** is based on total investments. "Other" sector category includes futures, options and certain other types of derivatives and are calculated using market value. Some portfolio derivatives may be included as part of different sectors based upon their underlying risk characteristics. The Investment-Grade Credit and High-Yield Credit sector categories may include credit default swaps, which are calculated using the notional exposure. "Net Cash & Equivalents" may include securities that have an expected maturity of less than 365 days. The final maturity of these securities may be longer.

**Quality Ratings** are assigned by credit rating agencies Standard & Poor's and Moody's as an indication of an issuer's creditworthiness. Ratings are measured on a scale that generally ranges from AAA (highest) to D (lowest). The highest credit quality rating available from these two rating agencies is used. Credit quality is subject to change.

**Duration** is a time measure of a bond's interest-rate sensitivity, based on the weighted average of the time periods over which a bond's cash flows accrue to the bondholder. Time periods are weighted by multiplying by the present value of its cash flow divided by the bond's price.

**Average Maturity** is computed by weighting the maturity of each security in the portfolio by the market value of the security, then averaging these weighted figures.

## Market Review

The Federal Open Market Committee (FOMC), acting in alignment with comments made by U.S. Federal Reserve (Fed) chairman Jerome Powell in November, raised the Fed funds target rate by 50 bps in December after four consecutive 75 bps hikes. Despite introducing a glide path down from aggressive rate hikes to an eventual pause in the first half of 2023, the overall tone from the Fed remained hawkish, encapsulated by Powell stating: “we’re not in a sufficiently restrictive policy stance yet.” Additional comments by Powell and other FOMC members indicated that even once a sufficiently restrictive policy rate is achieved, the Fed funds rate may need to stay ‘higher for longer’ in order to ensure that inflation is undeniably heading towards the Fed’s 2% long-term target.

The U.S. yield curve inversion (as measured by 2-year vs. 10-year yields) has reached levels last seen in the early 1980s. This signal, along with softening inflation data, weak leading economic indicators, and Purchasing Managers’ Index (PMI) prints that are now below 50 for both the manufacturing and services sectors, all point to a potential recession in 2023. The main holdout thus far has been the labor market, which remained extremely tight with a 3.5% unemployment rate as of December 2022.

The U.S. dollar continued its slide into year end, with the Bloomberg U.S. Dollar Spot Index declining 1.8% in December and 6.8% during the fourth quarter, in sharp contrast to the significant rally earlier in the year (+14.0% from January 2022 through September 2022). This reversal was driven by a divergence in monetary policies, as the Fed began to moderate its rate hikes at the same time that the European Central Bank (ECB) unexpectedly adopted a more hawkish stance and the Bank of Japan (BOJ) widened the band around the 0% target yield on its 10-year bond. These policy shifts helped the Euro and Yen, respectively, strengthen against the U.S. dollar.

The Bloomberg U.S. Aggregate (-0.45%) was down modestly in December due to a backup in risk-free rates. The investment-grade corporate option-adjusted spread (OAS) tightened by -3 bps, while high yield corporate OAS widened by +21 bps. MBS, CMBS, and ABS tightened by -1 bps, -8 bps, and -27 bps, respectively. U.S. Treasury rates rose and the curve inversion moderated in December: 3-month +2 bps (to 4.34%), 2-year +12 bps (to 4.43%), 5-year +27 bps (to 4.00%), 10-year +27 bps (to 3.87%), and 30-year +23 bps (to 3.96%). ## Portfolio Strategy

Exposure to U.S. corporate bonds declined slightly month-over-month but remained elevated, as the sector continued to offer moderately attractive relative value. The weight in high yield (HY) corporates increased month-over-month, as valuations became somewhat more attractive in December. Exposure to investment-grade (IG) corporates declined in December, with holdings skewed toward financials and industrials. The allocation to agency mortgage-backed securities (MBS) increased slightly month-over-month, while the weights in commercial mortgage-backed securities (CMBS) and asset-backed securities (ABS) were essentially unchanged and remained at low absolute levels. Exposure to non-U.S. dollar currency positions increased in December based on attractive long-term valuations combined with constructive short-term signals. The allocation to U.S. Treasuries declined modestly month-over-month, offset by an increase in cash equivalents. Portfolio duration increased slightly month-over-month and remained above the neutral range for the Fund, reflecting attractive real yields. Yield curve exposure continued to be somewhat bulleted in the 3-5 year segment, with minimal exposure to the 20+ year segment. Compared to the prior month, exposure to the 1-3 year and 3-5 year segments declined modestly, offset by small increases in the 0-1 year, 5-7 year, and 7-10 year segments.
